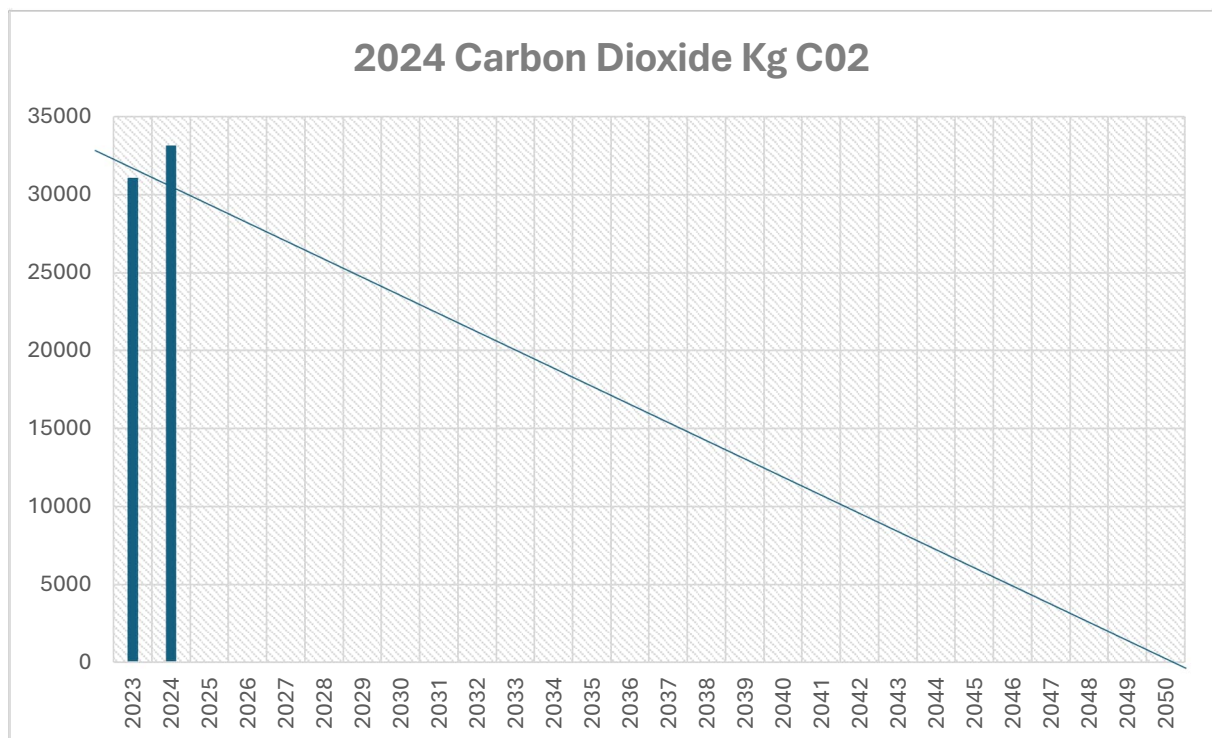

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next 25 years to 0 tCO₂e by 2050. This is a reduction of 100%

Completed Carbon Reduction Initiatives

As we are in our transition year we are planning changes to business and / staff transport reinforcing our environmental management measures under ISO14001 as the adoption of LED/PIR lighting controls, changes to policy resulting in a reduction in company travel and the electrification of the company fleet in 2025.

In the future we hope to implement further measures such as:
Decarbonisation of heating / cooling controls and reviewing suppliers with lower carbon footprints.

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

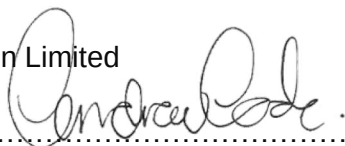
